This is a Contract between Bed, Bath & Biscuits LLC Boarding Kennels (hereinafter called "the kennel") and the pet owner whose signature appears below (hereinafter called "the owner"). This Contract applies to all pets being boarded by the owner at the kennel.

1. The owner agrees to pay the rate for boarding in effect on the date that the pet is checked into the kennel. The owner further agrees to pay all costs and charges for special services requested and all veterinary costs for the pet during the time that the said pet is in the care of the kennel. The owner further agrees that the pet shall not leave the kennel until all charges are paid to the kennel by the owner.

2. By signing this contract and leaving his or her pet with the kennel the owner certifies to the accuracy of all information given about the said pet.

3. The kennel shall exercise reasonable care for the pet delivered by the owner to the kennel for boarding. All pets are boarded by the kennel without liability on the kennel's part for loss or damage from disease, death, running away, theft, fire, injury to persons or other pets, or other unavoidable causes. It is expressly agreed by the owner and the kennel that the kennel's liability shall in no event exceed the lesser of the current chattel value of a pet of the

same species or the sum of \$200.00 per animal boarded. The owner further agrees to be solely responsible for any and all acts or behavior of the said pet while it is in the care of the kennel. The owner understands that all pets at Bed, Bath & Biscuits LLC are fully vaccinated. However, it is still possible for your dog or cat to become ill, even if vaccinated. The owner understands that this is not due to any circumstance or condition at the kennel and agrees to not hold the kennel liable in the event your pet becomes ill during or after his/her stay.

4. The owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances. The owner specifically represents to the kennel that the pet has not been exposed to rabies or distemper within a thirty-day period prior to boarding and that all vaccinations are up to date.

5. All charges incurred by the owner shall be payable upon pick-up of the pet. The kennel shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from boarding the pet at the kennel. In the event the boarding charges are not paid when due in accordance with this contract, the kennel may exercise its lien rights upon ten days written notice given by the kennel to the owner by certified mail to the address shown on the contract.

6. If the pet becomes ill or if the state of the animal's health otherwise requires professional attention, the kennel, in its sole discretion, may engage the services of a veterinarian or administer medicine or give other requisite attention to the animal, and the expenses thereof shall be paid by the owner.

7. All information about the pet(s) is accurate and up to date.

8. The contract contains the entire agreement between the parties.
